Michele Adamcyck reviewed the highlights of the Annual Audit and advised there are no issues of concern. In summary - the Village practices good fiscal controls and conservative expenditures with a healthy reserve equivalent to approximately 30% of total expenses.

Trustee Jake Kurkjian reported that Article 78 has been filed in relation to 27 The Terrace ZBA denial.

d. Utilities, OEM, MBPC - Deputy Mayor Don Richardson

Deputy Mayor Don Richardson reported << BP missing notes - will need to ask Don>>

e. Financial Update - Clerk/Treasurer Barbara Peebles

Clerk/Treasurer provided Revenue Expense Report. A separate mid-year review will be sent for the next meeting with highlights or any areas of concern. Other updates included: the reimbursement for the Firetruck was received, Manhasset Glen Escrow has been closed and \$25,000 was transferred to Capital for road repair, Mike Musso updated the Task Order for ExteNet engagement for an additional \$3000.00, the old Dump truck will be sold at auction, further details to follow.

IV) Unfinished business

a. Haberman Associates, Inc. – tax assessment support

Clerk/Treasurer Barbara Peebles suggested that the Village engage Haberman to assist with tax assessments. There is a significant increase expected since previous years Building Permits and CO's were 2.5 times higher than previous average. In addition the village froze tax roll 2021-2022 so a deeper analysis is required. [R12-2021-F]

- b. Approval to authorize Building Inspector to manage and enforce the 1020 Plandome Road/Greenhill Dev. landscaping plan to include Village berm as per SWPPP. *Tabled, Trustee Jake Kurkjian will follow up with David DeRienzis.*
- c. Resolution [R-12-2021-C] renew membership of Manhasset Bay Protection Committee.
- d. Resolution [R-12-2021-D] to appoint Assistant Village Prosecutor
- e. Resolution [R12-2021-E] to approve two firefighters to Plandome Fire Dept. roster
- f. Miscellaneous updates Technology.

Clerk/Treasurer Barbara Peebles indicated that IT is going to need some updating and enhancements. MuniTrak is ceasing operations by May 2022. Patriot software is recommended to improve the tax assessment process and their may be additional modules that can replace payroll, building permit, and other programs. The "technology project" will be scoped out for further consideration.

Resolution to amend the penalties as relates to dog bites.

In the Matter of the amendment to Chapter
Chapter 55: "Animals"; Article I: "Dog Control";
Section 13: "Penalties for Offenses", of the Code
of the Village of Plandome.

WHEREAS, the Village Board of the Incorporated Village of Plandome has noticed a Public Hearing with regard to a proposed amendment to the Village Code regulations the penalties related to violation of Chapter 55 of the Code, entitled "Animals";

WHEREAS, a Public Hearing on the adoption of the proposed local law was held on December 13, 2021.

WHEREAS, in accordance with the laws of the State of New York, at least 10 days prior to the Public Hearing, notification of same was published in the Official Paper of the Village of Plandome;

NOW THEREFORE, BE IT RESOLVED THAT Section 55-13 of the Village Code of the Incorporated Village of Plandome is hereby amended as follows:

§ 55-13 PENALTIES FOR OFFENSES:

Unless otherwise provided by Article 7 of the New York State Agriculture and Markets Law, any person, firm or corporation who or which shall violate any of the provisions of this chapter shall, upon conviction, be punished as follows:

- (A) For a first offense, by a fine of not more than one thousand dollars (\$1,000.00) or imprisonment for not more than 15 days, or both;
- (B) For a second offense, by a fine of not more than two thousand dollars (\$2,000.00) or imprisonment for not more than 15 days, or both; and
- (C) For a third or subsequent offense within five (5) years by a fine of not more than five thousand (\$5,000.00) or imprisonment for not more than 15 days, or both.

BE IT FURTHER RESOLVED, that if a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstances is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

BE IT FURTHER RESOLVED, the Village the Board of Trustees approves the amendments to Village Code Chapter 55, as proposed and this local law shall take effect immediately upon filing with the Secretary of State.
